## CITY OF TORONTO

### BY-LAW No. 57-1999

#### To authorize the removal of certain trees growing on the highways of the Municipality.

WHEREAS the *Municipal Act*, R.S.O. 1990, Chapter M.45, Section 312, subsection 4(e) provides that the Council of every municipality may pass by-laws causing any tree planted upon a highway within the municipality to be removed when considered necessary in the public interest; and

WHEREAS it is considered necessary in the public interest to cause the trees hereinafter designated, growing on the highways of the municipality, to be removed;

Now therefore the Council of the City of Toronto HEREBY ENACTS as follows:

1. The Commissioner of Economic Development, Culture and Tourism be and he is hereby authorized and instructed to cut down and remove, or cause to be cut down and removed, the trees standing in the following highways,

**Buttonwood Ave. (77)** One (1) Manitoba Maple, standing on the South side of Buttonwood Ave., abutting PT Lot 2, Conc. 5 WY on which is situated house #77.

**Reason for removal:** *Tree in poor condition.*

**Church St. (181)** One (1) Fir tree, standing on the South side of Church St., abutting W PT Lot 191, Plan M140 on which is situated house #181.

**Reason for removal:** *Tree in poor condition.*

**Denison Rd. W. (15)** One (1) Norway Maple tree, standing on the East side of Denison Rd. W., abutting PT Lots B1 & C1, Plan 500 on which is situated house #15.

**Reason for removal:** *Tree in very poor condition.*

**Flanders Rd. (9)** One (1) Norway Maple tree, standing on the East side of Flanders Rd., abutting N PT Lot 27, Plan 3042 on which is situated house #9.

**Reason for removal:** *Back half of tree is dead.*

**Magwood Crt. (11)** One (1) Spruce tree, standing on the South side of Magwood Crt., abutting S PT Lot 31, Plan 4720 on which is situated house #11.

**Reason for removal:** *Most of the tree is dead.*

**Methuen Ave. (64)** One (1) Sugar Maple tree, standing on the South side of Methuen Ave., abutting PT Lot 135, Plan 1352 on which is situated house #64.

***Reason for removal:*** *Top half of tree is dead.*

**Patika Ave. (49)** One (1) Norway Maple tree, standing on the South side of Patika Ave., abutting PT Lots 175 and 176, Plan M465 on which is situated house #49.

***Reason for removal:*** *Tree in poor condition.*

**Westacres Dr. (22)** One (1) Spruce tree, standing on the North side of Westacres Dr., abutting E PT Lot 2 and W PT Lot 12, Plan 3278 on which is situated house #22.

***Reason for removal:*** *Tree is 3/4 dead.*
