CITY OF TORONTO

BY-LAW No. 263-1999

**To amend the former City of Toronto Municipal Code Ch. 400,
Traffic and Parking, respecting Bernard Avenue, Queen Street East, Lane first north of
Eglinton Avenue West, Windermere Avenue, Worthington Crescent.**

The Council of the City of Toronto HEREBY ENACTS as follows:
