## CITY OF TORONTO

### BY-LAW No. 288-1999

**To amend By-law No. 64-87, a By-law “For Prohibiting and Regulating the Erection of Signs and Other Advertising Devices”, being a by-law of the former Borough of East York.**

The Council of the City of Toronto HEREBY ENACTS as follows:

**1.** By-law No. 54-87, a By-law “For Prohibiting and Regulating the Erection of Signs or Other Advertising Devices” as amended, being a by-law of the former Borough of East York, is further amended by inserting Article 4.2.6. following Article 4.2.5. as follows:

“4.2.6. Notwithstanding Sentence 4.2.1. (c), the following signs, as shown on the drawings prepared by Steel Art Signs in Markham, Ontario date stamped received October 13, 1998, shall be permitted to be installed for Burger King restaurant, located at the property known as 3003 Danforth Avenue, in the year 1999:

- (a) two (2) square signs, having sides of 0.9 metres (3'-0") identified as sign No.2 on the wall elevation drawings;
- (b) one (1) sign having an overall length of 4.57 metres (15'-0") and a height of 0.68 metres (2'-3"), identified as sign No. 4 on the wall elevation drawings;
- (c) one (1) second sign, over the entrance to the restaurant, having an overall length of 3.65 metres (12'-0") and a height of 1.5 metres (5'-0"), identified as sign No. 5 on the wall elevation drawings;
- (d) one (1) canopy, with no wording, over the pick-up window, having an overall length of 3.6 metres (12'-0") and a height of 1.5 metres (5'-0"), identified as sign No. 7 on the wall elevation drawings;
- (e) one (1) pre-menu board sign, having an overall height of 1.39 metres (4'-7") and an aggregate area of 0.63 square metres (6.78 square feet), identified as sign No. 8 on the site plan;
- (f) one (1) menu board sign, having an overall height of 2.10 metres (6'-11") and an aggregate area of 2.38 square metres (25.64 square feet), identified as sign No. 9 on the site plan; and
- (g) three (3) directional signs: one (1) at the parking area nearest to the Burger King restaurant; one (1) at the drive thru-entrance; and one (1) at the drive-thru exit, identified as sign No. 10 on the site plan.”
