## CITY OF TORONTO

### BY-LAW No. 354-1999

#### To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

3. Schedule XV (Prohibited Turns) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Bathurst Street and College Street	Eastbound and Westbound	Left	4:00 p.m. to 6:00 p.m. Monday to Friday
St. Clair Avenue West between Dufferin Street and Oakwood Avenue (M.T. 14)	Eastbound and Westbound	U-Turns	Anytime

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:
