CITY OF TORONTO

BY-LAW No. 361-1999

To amend Procedural By-law No. 23-1998.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Section 11 of By-law No. 23-1998 is amended by
 - (a) deleting subsections 11(2), (3) and (4);
 - (b) adding a new subsection (2) as follows:

“Subject to subsections (4), (5) and (6), the Council shall adjourn at 7:30 p.m. on the first or second day of meeting until 9:30 a.m. on the following day.”
 - (c) renumbering subsections (5) to (9) as subsections (3) to (7) and revising references to these subsections accordingly.
2. Section 83 of By-law No. 23-1998 is renumbered as section 89.
3. Sections 103 to 130 of By-law No. 23-1998 are renumbered as sections 102 to 129.
4. Section 115 of By-law No. 23-1998 is amended to delete the references to section 112 and replace it with reference to section 111.
5. Section 116(6) of By-law No. 23-1998 is amended to delete the reference to section 109 and replace it with reference to section 108.
6. Sections 122(2) and 130(2) of By-law No. 23-1998 are amended to delete the reference to section 121(a) and replace it with reference to section 120(a).
7. Section 116(3) of By-law No. 23-1998 is deleted and replaced with the following:
 - “(3) (a) A quorum for a joint meeting pursuant to this section shall be calculated on the basis of one-half of the combined Members of both Committees excluding ex-officio Members, unless Council decides otherwise; and
 - (b) ex-officio Members, when present, shall be counted in making such quorum.”

- 8.** Section 12 of By-law No. 150-1999 is amended so that paragraphs marked as 94 and 95 will read as 95 and 96, respectively.
- 9.** Section 13 of By-law No. 150-1999 is amended to read sections 90 to 94, not 89 to 93.
- 10.** Section 14 of By-law No. 150-1999 is amended to read sections 97 and 98, not 96 and 97.
- 11.** Section 15 of By-law No. 150-1999 is amended to read section 99, not 98.
- 12.** Sections 17 and 18 of By-law No. 150-1999 are amended so that new sections read 100 and 101, respectively, not 99 and 100.
- 13.** Sections 19 and 20 of By-law No. 150-1999 are amended to read sections 104 and 105, respectively, not 103 and 104.
- 14.** Sections 22, 23, 24, 25, 27 and 29 of By-law No. 150-1999 are deleted.
- 15.** Section 28 of By-law No. 150-1999 is amended to refer to a new section 130, not section 128.
