CITY OF TORONTO

BY-LAW No. 731-1999

To amend the former City of Toronto Municipal Code Chapter 20, Business Improvement Areas, to make changes to the size and quorum for certain Boards of Management and to make changes to ward names.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code, Chapter 20, Business Improvement Areas, of the former City of Toronto, is amended as follows:

The table in Schedule "A" is amended by:

- (1) Amending the numbers set out opposite "Bloor/Bathurst Madison" by deleting "10" and substituting "11", effective from September 28, 1999.
- (2) Amending the numbers set out opposite "Bloordale Village" by deleting "2" and substituting "4", effective from September 28, 1999.
- (3) Amending the numbers set out opposite "Bloor Yorkville" by deleting "3" and substituting "4", effective from September 28, 1999.
- (4) Amending the numbers set out opposite "Danforth by The Valley" by deleting "12" and substituting "10", and by deleting "6" and substituting "5", effective from September 28, 1999.
- (5) Amending the numbers set out opposite "Eglinton Way" by deleting "9" and substituting "10", effective from September 28, 1999.
- (6) Amending the numbers set out opposite "Hillcrest Village" by deleting "7" and substituting "5", and by deleting "4" and substituting "3", effective from September 28, 1999.
- (7) Amending the numbers set out opposite "Roncesvalles Village" by deleting "13" and substituting "12", effective from September 28, 1999.
- (8) Amending the numbers set out opposite "Dovercourt Village" by deleting "11" and substituting "Davenport", effective from September 28, 1999.
- (9) Amending the numbers set out opposite "Elm Street" by deleting "5, 6" and substituting "Downtown", effective from September 28, 1999.

- (10) Amending the numbers set out opposite “St. Clair Gardens” by deleting “1” and substituting “2”, and by deleting “12” and substituting “Davenport”, effective from September 28, 1999.
- (11) Amending the numbers set out opposite “Upper Village” by deleting “15” and substituting “North Toronto”, effective from September 28, 1999.
- (12) Amending the numbers set out opposite “Yonge/Queen-Dundas” by deleting “6” from under the heading “Ward” and substituting “Downtown”, effective from September 28, 1999.
