**CITY OF TORONTO**

**BY-LAW No. 772-1999**

**To amend By-law No. 31001 of the former City of North York, as amended.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "XVIII" of By-law No. 31001 of the former City of North York is amended by deleting from Columns 1 and 2 the following:
