BY-LAW No. 845-1999

To amend By-law No. 31878, as amended, of the former City of North York.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. That Section 1 of By-Law Number 31878 of the former City of North York is amended by deleting the following:
