BY-LAW No. 17-2000

**To amend the former City of Toronto Municipal Code Ch. 400,
Traffic and Parking, respecting Golden Avenue, Guest Avenue, Hillsdale Avenue West,
Morrow Avenue, Silver Avenue, Sorauren Avenue, Swanwick Avenue, The Esplanade,
Triller Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule IV (Stop Intersections) in §400-57, the following in alphabetical order by street name:

Golden Avenue and Silver Avenue	Silver Avenue (westbound)
Morrow Avenue and Silver Avenue	Silver Avenue (eastbound)

B. By inserting in Schedule XVI (Speed Limits on Highways) in §400-69, the following in alphabetical order by street name:
