BY-LAW No. 144-2000

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Edgewood Avenue, Elm Avenue, Hilton Avenue, Lytton Boulevard, Montclair Avenue, Roxborough Street West, Rusholme Road, Spadina Road, Stafford Street, Summerhill Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting a new Subsection (g.1) after Subsection (g) in §400-33 D(1) as follows:

“g.1) Subsection (g) does not apply to the following locations (s):

Summerhill Avenue, north side, between a point 54 metres east of Yonge Street and a point 36 metres further east thereof (T.T.C. overpass)”.
