BY-LAW No. 294-2000

**To amend the former City of Toronto Municipal Code Ch. 400,
Traffic and Parking, respecting Colbeck Street, Runnymede Road.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in §400-76, the following in alphabetical order by street name:

Runnymede Road	East	Colbeck Street and Glenwood Avenue	8:30 a.m. to 6:00 p.m., Mon. to Sat.

B. By inserting in Schedule XXIII (No Parking Certain Times) in §400-76, the following in alphabetical order by street name:

Runnymede Road	East	A point 207 metres north of Colbeck Street and Glenwood Avenue	8:30 a.m. to 6:00 p.m., Mon. to Sat.

Runnymede Road	East	A point 76 metres north of Colbeck Street and a point 131 metres further north thereof	9:30 a.m. to 11:30 a.m. and 1:00 p.m. to 3:00 p.m., Mon. to Sat.

C. By inserting in Schedule XXIV (No Stopping) in §400-77, the following in alphabetical order by street name:

D. By inserting in Schedule XXV (Time Limit Parking) in §400-78, the following in alphabetical order by street name:

Runnymede Road	East	A point 76 metres north of Colbeck Street and a point 131 metres further north thereof	8:00 a.m. to 9:30 a.m., 11:30 a.m. to 1:00 p.m., and 3:00 p.m. to 6:00 p.m., Mon. to Sat.	15 mins.
