AMENDMENT NO. 1051 TO THE OFFICIAL PLAN

OF THE

FORMER CITY OF SCARBOROUGH

CITY INITIATED

EAST SIDE OF BIRCHMOUNT ROAD

BETWEEN PARNELL AVENUE AND RALEIGH AVENUE

The following Text and Map constitutes Amendment No. 1051, being an amendment to the provisions of the former City of Scarborough Official Plan.

The sections headed "Purpose and Location" and "Basis" are explanatory only, and shall not constitute part of this amendment.

PURPOSE AND LOCATION:

This amendment affects the industrial lands located on the east side of Birchmount Road between Parnell Avenue and Raleigh Avenue, as shown on the attached Schedule “T”. The amendment adds an Industrial District Commercial designation to the existing General Industrial Uses with High Performance Standards designation.

BASIS:

This amendment will provide additional land uses and will expand the opportunity for the future development of this area by permitting more diversified employment opportunities. The introduction of additional land uses will potentially bring more investment to the area and revitalize this portion of the street, and also provide the potential for improvements to the Birchmount Road streetscape.

OFFICIAL PLAN AMENDMENT:

- A. The Birchmount Park Employment District Secondary Plan Land Use Map, Figure 4.35, is amended for the lands located on the east side of Birchmount Road between Parnell Avenue and Raleigh Avenue, by adding Numbered Policy 4, as indicated on the attached Schedule “T”.
- B. The Birchmount Park Employment District Secondary Plan is amended by adding Numbered Policy 4 as follows:
 4. **East Side of Birchmount Road between Parnell Avenue and Raleigh Avenue**

The **Industrial District Commercial** designation applies in addition to the **General Industrial Uses with High Performance Standards** designation.
- C. City of Toronto By-law No. 27-2000 is hereby repealed.
