BY-LAW No. 419-2000

**To amend former City of York By-law No. 2958-94, being a By-law
“To regulate traffic on City of York Roads”.**

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

Column 1	Column 2	Column 3	Column 4
<u>Highway</u>	<u>Side</u>	<u>Between</u>	<u>Prohibited Times or Days</u>
East Drive	North	Scarlett Road and Jane Street	4:00 p.m. to 6:00 p.m., Monday to Friday

NO PARKING - SCHEDULE VIII

2. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

Column 1	Column 2	Column 3	Column 4
<u>Highway</u>	<u>Side</u>	<u>Between</u>	<u>Prohibited Times or Days</u>
Ellins Avenue	North	Duern Street and a point 33.2 metres east thereof	Anytime
Lonborough Avenue	South	Richardson Avenue and a point 24.8 metres east thereof	Anytime

THROUGH HIGHWAYS – SCHEDULE XVIII

3. That Schedule XVIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1 and 2 of said Schedule the following:

Column 1	Column 2
<u>Highway</u>	<u>Between</u>
East Drive	The east limit Scarlett Road and the west limit Jane Street

STOP SIGNS – SCHEDULE XIX

4. That Schedule XIX of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1 and 2 of said Schedule the following:

Column 1	Column 2
<u>Intersection</u>	<u>Stop Streets</u>
Brendwin Road and East Drive	Brendwin Road for southbound traffic
Bexley Crescent and East Drive	Bexley Crescent for southbound traffic
East Drive and Woodgate Drive/Brendwin Road	East Drive for east and westbound traffic
Woodgate Drive and East Drive	Woodgate Drive for northbound traffic
