CITY OF TORONTO

BY-LAW No. 515-2000

**To designate certain lands on a registered plan of subdivision in the
North York Humber Community as being exempt from Part-Lot Control.**

WHEREAS authority is given to Council by subsection 50(7) of the *Planning Act* to pass this By-law;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Subsection 50(5) of the *Planning Act* does not apply to the lands described in the attached Schedule "A"; and
2. That this By-law shall expire twelve months from the day of its passage by Council.
