**CITY OF TORONTO**

**BY-LAW No. 519-2000**

**To amend further By-law No. 23503 of the former City of Scarborough,  
respecting the regulation of traffic on Toronto Roads.**

The Council of the City of Toronto HEREBY ENACTS as follows:
