BY-LAW No. 573-2000

**To amend the former City of Toronto Municipal Code Ch. 400,
Traffic and Parking, respecting Booth Avenue, Leslie Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in §400-76, the following in alphabetical order by street name:

Booth Avenue	West	Queen Street East and the lane first south of it	Anytime

Leslie Street	East	A point 234 metres north of Queen Street East and a point 91.4 metres further north thereof	9:00 a.m. to 11:30 a.m., 1:00 p.m. to 3:00 p.m. and 4:00 p.m. to 5:00 p.m., Mon. to Fri.

C. By inserting in Schedule XXV (Time Limit Parking) in §400-78, the following in alphabetical order by street name:

Leslie Street	East	A point 234 metres north of Queen Street East and a point 91.4 metres further north thereof	8:00 a.m. to 9:00 a.m., 11:30 a.m. to 1:00 p.m. and 3:00 p.m. to 4:00 p.m., Mon. to Fri.	10 mins.
