CITY OF TORONTO

BY-LAW No. 589-2000

**To amend the former City of Toronto Municipal Code Ch. 400,
Traffic and Parking, to provide for dedicated motorcycle parking spots.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting a new Subsection (c.1) after Subsection (c) in §400-33E(1) as follows:

(c.1) Subsection (c) does not apply to a motorcycle parked at the following location(s) during the following time(s):

Highway	Side	Location	Times
Hoskin Avenue	North	Between a point 8.0 metres west of Devonshire Place and a point 1.0 metre further west	Anytime

B. By inserting a new Subsection (a.1) after Subsection (a) in §400-33H(1) as follows:

(a.1) Subsection (a) does not apply to a motorcycle parked at the following location(s) during the following time(s):

Highway	Side	Location	Times
Victoria Street	West	Between a point 14.0 metres south of Dundas Square and a point 1.0 metre further south	Anytime

C. By inserting a new Subsection (b.2) after Subsection (b.1) in §400-33H(1) as follows:

(b.2) Subsection (b) does not apply to a motorcycle parked at the following location(s) during the following time(s):

Highway	Side	Location	Times
Albert Street	North	Between a point 29.0 metres east of Bay Street and a point 1.5 metres further east	Anytime

D. By deleting from Schedule XXIII (No Parking Certain Times) in §400-76, the following in alphabetical order by street name:

Elm Street	North	A point 20.0 metres west of Yonge Street and a point 3.0 metres further west thereof	Anytime (motorcycles excepted)
Hoskin Avenue	North	A point 8.0 metres west of Devonshire Place and a point 6.0 metres further west thereof	Anytime (motorcycles excepted)
