BY-LAW No. 608-2000

To amend further By-law No. 20-96, "Being a by-law to provide for overnight permit parking on Borough streets", being a by-law of the former Borough of East York.

WHEREAS in order to provide for permit parking between the hours of 12:01 a.m. to 7:00 a.m., 7 days a week, it is necessary to create a new Schedule "B" of the former Borough of East York By-law No. 20-96; in order to provide for permit parking between the hours of 12:01 a.m. to 10:00 a.m., 7 days a week, it is necessary to create a new Schedule "C" of the former Borough of East York By-law No. 20-96; in order to provide for permit parking between the hours of 12:01 a.m. to 9:00 a.m., 7 days a week, it is necessary to create a new Schedule "D" of the former Borough of East York By-law No. 20-96; and in order to provide for permit parking between the hours of 12:00 midnight to 11:00 a.m., 4:00 p.m. to 7:00 p.m., Monday to Friday, and 12:01 a.m. to 10:00 a.m., Saturday and Sunday, it is necessary to create a new Schedule "E" of the former Borough of East York By-law No. 20-96;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 20-96 of the former Borough of East York, as amended, being a By-law to provide for overnight permit parking on former Borough Streets, is amended as follows:

- A. By inserting in Section 1.10 the words: ", Schedule "B", Schedule "C", Schedule "D", or Schedule "E" " after the words: "designated in Schedule "A" " and before the word: "within".
- B. By inserting in Section 1.15 the words: ", Schedule "B", Schedule "C", Schedule "D", or Schedule "E" " in the second line after the words: "Schedule "A" " and before the word: "or".
- C. By deleting Section 3.1 and inserting in lieu thereof the following:

"3.1 Permits shall only be issued for the Streets, on the sides and at the locations set out in Columns 1, 2 and 3 of Schedule "A", Schedule "B", Schedule "C", Schedule "D", or Schedule "E", for the number of Parking Spaces set out in Column 4 of the respective Schedule "A", Schedule "B", Schedule "C", Schedule "D", or Schedule "E" and for use between the hours set out in Column 5 of the respective Schedule "A", Schedule "B", Schedule "C", Schedule "D", or Schedule "E". The Streets designated in Schedules "A", "B", "C", "D", and "E" may be amended from time to time by by-law of Council".

- D. By deleting Section 3.2 and inserting a new Section 3.2 as follows:
- “3.2 Council may designate a Parking Area comprised of specified Streets designated in a Schedule attached to By-law No. 20-96, as amended, and such Parking Area shall be identified in Column 6 of said Schedule”.
- E. By inserting in Section 3.3 the words: “, Schedule “B”, Schedule “C”, Schedule “D”, or Schedule “E” ” after the words: “designated in Schedule “A” ”.
- F. By deleting Section 3.4 of By-law No. 20-96, as amended.
- G. By inserting in Section 3.5 the words: “, Schedule “B”, Schedule “C”, Schedule “D”, or Schedule “E” ” in the first line after the words: “Schedule “A” ”.
- H. By inserting in the third line of Section 4.1 the words: “, Schedule “B”, Schedule “C”, Schedule “D”, or Schedule “E” ” after the words: “Schedule “A” ” and before the word: “hereto”.
- I. By inserting in the third line of Section 5.3 the words: “, Schedule “B”, Schedule “C”, Schedule “D”, or Schedule “E” ” after the words: “Schedule “A” ” and before the word: “and”.
- J. By inserting in the third line of Section 5.6 the words: “, Schedule “B”, Schedule “C”, Schedule “D”, or Schedule “E” ” after the words: “Schedule “A” ” and before the word: “or”.
- K. By inserting in Section 5.10 the words: “, Schedule “B”, Schedule “C”, Schedule “D”, or Schedule “E” ” after the words: “Schedule “A” ” and before the word: “within”.
- L. By inserting in Section 8.8 the words: “, “D”, and “E” ” after the words: “Schedules “A”, “B” and “C” ” and before the word: “attached”.
- M. By inserting in Section 8.11 the words: “, “Schedule “B”, Schedule “C”, Schedule “D”, and Schedule “E” ” after the words: “Schedule “A” ” and before the word: “shall”.
- N. By amending Schedule “A” by striking out the following words and figures where they appear in Columns 1, 2, 3, 4, 5 and 6 of the said Schedule:
