CITY OF TORONTO

BY-LAW No. 687-2000

To amend further Metropolitan Toronto By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Eglinton Avenue (M.T. 18)	South	Caledonia Road and Kirknewton Road	4:00 p.m. to 6:00 p.m. except Saturdays, Sundays and Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3 and 4 of the said Schedule:
