**CITY OF TORONTO**

**BY-LAW No. 862-2000**

**To layout and dedicate certain land for public lane purposes and to layout and dedicate certain land for public highway purposes and to name those public highways Açores Avenue and Minho Boulevard, respectively.**

WHEREAS as part of the Committee of Adjustment approval for the development of 1090 Shaw Street, certain land was provided for public lane and public highway purposes;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Certain land to form part of the public lane, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

Part of Parcel 52-1 in the Register for Section A-197-Y.

Being composed of parts of Lots 52, 53, 54, 55, 56, 57, 59 and 60 on Plan 197-York registered in the Land Registry Office for the Metropolitan Toronto Registry Division (No. 64) designated as PARTS 3 and 10 on Plan 66R-17747 and PART 25 on Plan 66R-18345, both said Plans being deposited in the Land Registry Office for the Land Titles Division of Metropolitan Toronto (No. 66)

is laid out and dedicated for public lane purposes.

2. Certain land, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

Part of Parcel 52-1 in the Register for Section A-197-Y.

Being composed of parts of Lots 54 and 55 on Plan 197-York registered in the Land Registry Office for the Metropolitan Toronto Registry Division (No. 64) designated as PART 60 on Plan 66R-18192 deposited in the Land Registry Office for the Land Titles Division of Metropolitan Toronto (No. 66)

is laid out and dedicated for public highway purposes and is named Açores Avenue.

3. Certain land, described by W. Kowalenko, O.L.S., City Surveyor, as follows, namely:

Part of Parcel 52-1 in the Register for Section A-197-Y.

Being composed of parts of Lots 55, 56, 59 and 60 on Plan 197-York registered in the Land Registry Office for the Metropolitan Toronto Registry Division (No. 64) designated as PARTS 47 and 48 on Plan 66R-18345 deposited in the Land Registry Office for the Land Titles Division of Metropolitan Toronto (No. 66)

is laid out and dedicated for public highway purposes and named Minho Boulevard.
