CITY OF TORONTO

BY-LAW No. 873-2000

A by-law to amend City of Toronto By-law No. 23-1998, being “A By-law to govern the proceedings of Council and the Committees thereof”.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 23-1998, being “A By-law to govern the proceedings of the Council and the Committees thereof”, as amended, is further amended by adding the following new subsection 17.3: “17.3 requests for time specific consideration of items shall be dealt with immediately after Council determines which items on the Agenda are to be held for debate”.

2. Subsection 17(3) of By-law No. 23-1998 is amended by adding after the words “make any such alteration of the order of business” the words and punctuation (“whether or not the time for considering such business has previously been determined by Council”).

3. Section 40 of By-law No. 23-1998 is amended by deleting the words “the question” and substituting therefor “an entire clause”.

4. Subsection 46(3) of By-law No. 23-1998 is amended by adding at the beginning of this sentence the words “A motion for reconsideration is not debatable, and”.

5. Section 57 of By-law No. 23-1998 is amended by substituting “Section 55” for the reference to “Section 54”.

6. Subsections 27(4), 92(b) and 92.1(6) of By-law No. 23-1998 is amended to delete the words “Urban Environment and Development Committee” and the words “Commissioner of Urban Planning and Development and substitute therefor “Planning and Transportation Committee” and “Commissioner of Urban Development Services”.

7. Section 91 of By-law No. 23-1998 is amended by deleting numbered items (1) through (6), and that at such time as Council determines the names to be given to the Community Councils, the Council Procedural By-law be amended accordingly, without the need for further notice to be given

8. Subsections 95(2) and (3) of By-law No. 23-1998 are amended by deleting “eleven (11)” and replacing them with “eight (8)”.

9. Subsections 95(4), (5) and (6) of By-law No. 23-1998 are amended by deleting the words “ten (10)” and replacing them with “eight (8)”.

10. Section 94 of By-law No. 23-1998 is amended by deleting the reference to “section 93.1(6)” and replacing it with a reference to “section 92.1(6)”.

11. Sections 7, 8, 9, 10 and 13 of this amending by-law take effect as of December 1, 2000.

12. Subsection 112(4) of By-law No. 23-1998 is deleted.
