BY-LAW No. 878-2000

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Cedarvale Avenue, Hampton Avenue, Kewbeach Avenue, Kingsmount Park Road, Park Road, Quebec Avenue, Ryding Avenue, Trinity Street, Wildwood Crescent.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
