BY-LAW No. 888-2000

**To amend further Metropolitan By-law No. 32-92, respecting the regulation
of traffic on former Metropolitan Roads.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Bloor Street (M.T. 10)	North	Brock Avenue and Russett Avenue	7:00 a.m. to 9:00 a.m. except Saturdays, Sundays and Public Holidays
Bloor Street West (M.T. 10)	South	Brock Avenue and Dufferin Street	4:00 p.m. to 6:00 p.m. Monday to Friday except Public Holidays

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:
