BY-LAW No. 931-2000

To amend further Metropolitan Toronto By-law No. 20-85, a by-law “Respecting the licensing, regulating and governing of trades, callings, businesses and occupations in the Metropolitan Area”, a by-law of the former Municipality of Metropolitan Toronto, and By-law No. 574-2000, respecting licence fees.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The number “96” contained in Column 2 opposite the words “for renewal” contained in Column 1 under the licence category of “Cabs”, sub-category of “Taxicab Drivers”, in Schedule 1 to By-law No. 20-85, as amended, a by-law “Respecting the licensing, regulating and governing of trades, callings, businesses and occupations in the Metropolitan Area”, a by-law of the former Municipality of Metropolitan Toronto, is deleted and the number “146” is substituted in lieu thereof.
2. The year “2000” contained in the date “December 31, 2000” in Column 3 opposite the words “ambassador taxicabs - when issued to a cab driver on the waiting list” contained in Column 1 under the licence category of “Cabs”, sub-category of “Taxicab Owners”, in Schedule 1 to By-law No. 20-85, as amended, is deleted.
3. Column 1 under the licence category of “Cabs”, sub-category of “Taxicab Owners”, in Schedule 1 to By-law No. 20-85, as amended, is further amended by adding thereto the words “for renewal – ambassador taxicabs” and Column 3 opposite such words is amended by adding the number “604”.
4. The number “96” contained in Column 2 opposite the words “for renewal” contained in Column 1 under the licence category of “Cabs”, sub-category of “Taxicab Drivers”, in Schedule 1 to By-law No. 574-2000, as amended, a by-law “Respecting the licensing, regulating and governing of trades, businesses and occupations in the City of Toronto”, is deleted and the number “146” is substituted in lieu thereof.
5. The year “2000” contained in the date “December 31, 2000” in Column 3 opposite the words “ambassador taxicabs – when issued to a cab driver on the waiting list” contained in Column 1 under the licence category of “Cabs”, sub-category of “Taxicab Owners”, in Schedule 1 to By-law No. 574-2000, as amended, is deleted.
6. Column 1 under the licence category of “Cabs”, sub-category of “Taxicab Owners”, in Schedule 1 to By-law No. 574-2000, as amended, is further amended by adding thereto the words “for renewal - ambassador taxicabs” and Column 3 opposite such words is amended by adding the number “604”.

7. (1) Section 1 of this by-law shall be deemed to have come into force on August 3, 2000.
- (2) Sections 2 and 3 of this by-law shall come into force on the date of enactment of this by-law.
- (3) Sections 4, 5 and 6 of this by-law shall come into force on January 1, 2001.
