**CITY OF TORONTO**

**BY-LAW No. 935-2000**

**To amend By-law No. 20-96 of the former Borough of East York, being “A By-law to provide for overnight permit parking on former Borough Streets”, to provide for carsharing parking permits.**

WHEREAS City Council has decided to establish a new category of on-street parking permits for carsharing vehicles and has directed that all City by-laws pertaining to the issuance of parking permits be amended accordingly;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 20-96 of the former Borough of East York, being “A By-law to provide for overnight permit parking on former Borough Street”, is amended by inserting a new Section 9.0 after Section 8, as follows:

“9.0 Carsharing Parking Permits

9.1 In this section, “Carsharing” shall mean the practice of sharing the use of one or more Motor Vehicles owned by a profit or non-profit residentially-based carsharing organization, where:

- (a) the Motor Vehicles are Parked for convenient access within the area of the membership served by the organization; and
- (b) persons using the vehicles are members of the carsharing organization who pay a refundable or non-refundable membership fee for the privilege of reserving and using the Motor Vehicles on a fee for use basis.

9.2 The provisions of Sections 1.0, 2.0, 3.0, 4.0, 5.6, 5.7, 5.8, 5.9, 6.0, 7.0 and 8.0 apply to Carsharing Parking Permits with necessary modification.

9.3 Persons applying for a Carsharing Parking Permit pursuant to this section shall complete a City application form, including the following information:

- (a) the name and address of the registered Owner of the Motor Vehicle for which the Permit is applied for;
- (b) the licence number, make and year of the Motor Vehicle; and
- (c) the date.

- 9.4 A Carsharing Parking Permit shall contain the number of the Permit, the name of the Street or, where applicable, the appropriate permit Parking Area(s) where the Motor Vehicle may be parked and the Permit Period for which the Permit is issued.
- 9.5 A Carsharing Parking Permit:
- (a) May be issued for a designated Parking Area, in which case it shall only be applicable for those Streets within the designated permit Parking Area; and
  - (b) May be issued for highway specific permit parking only where there are permit parking spaces available on the specific Street.
- 9.6 The total number of Carsharing parking Permits issued under City by-laws relating to permit parking shall not exceed 25 for the period from October 1, 2000 to September 30, 2001.
- 9.7 There shall be no Permit Fee payable for Carsharing parking Permits issued for the period set out in subsection 9.6”.
