BY-LAW No. 952-2000

**To amend City of Toronto By-law No. 23-1998 to re-establish Community Councils in the
City of Toronto.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. By-law No. 23-1998, being a By-law “To Govern the Proceedings of the Council and the Committees thereof”, as amended, is further amended by amending section such that the section now reads:

90. There shall be six community councils established for the City of Toronto.

2. By-law No. 23-1998, being a By-law “To Govern the Proceedings of the Council and the Committees thereof”, as amended, is further amended by deleting section 91 and inserting in lieu the following section:

91. (1) The community councils shall be named:

- (a) the West Community Council;
- (b) the North Community Council;
- (c) the Southwest Community Council;
- (d) the Midtown Community Council;
- (e) the Downtown Community Council; and
- (f) the East Community Council.

(2) Each community council shall consist of that part of the urban area, which includes the following city electoral wards:

(a) the West Community Council shall include:

- (i) Ward 1, Etobicoke North;
- (ii) Ward 2, Etobicoke North;
- (iii) Ward 3, Etobicoke Centre;
- (iv) Ward 4, Etobicoke Centre;
- (v) Ward 5, Etobicoke-Lakeshore;
- (vi) Ward 6, Etobicoke-Lakeshore.

(b) the North Community Council shall include:

- (i) Ward 7, York West;
- (ii) Ward 8, York West;
- (iii) Ward 9, York Centre;
- (iv) Ward 10, York Centre;
- (v) Ward 23, Willowdale;

- (vi) Ward 24, Willowdale;
 - (vii) Ward 33, Don Valley East.
- (c) the Southwest Community Council shall include:
- (i) Ward 11, York South-Weston;
 - (ii) Ward 12, York South-Weston;
 - (iii) Ward 13, Parkdale-High Park;
 - (iv) Ward 14, Parkdale-High Park;
 - (v) Ward 15, Eglinton-Lawrence;
 - (vi) Ward 17, Davenport;
 - (vii) Ward 18, Davenport.
- (d) the Midtown Community Council shall include:
- (i) Ward 16, Eglinton-Lawrence;
 - (ii) Ward 21, St. Paul's;
 - (iii) Ward 22, St. Paul's;
 - (iv) Ward 25, Don Valley West;
 - (v) Ward 26, Don Valley West;
 - (vi) Ward 34, Don Valley East.
- (e) the Downtown Community Council shall include:
- (i) Ward 19, Trinity-Spadina;
 - (ii) Ward 20, Trinity-Spadina;
 - (iii) Ward 27, Toronto Centre-Rosedale;
 - (iv) Ward 28, Toronto Centre-Rosedale;
 - (v) Ward 29, Broadview-Greenwood;
 - (vi) Ward 30, Broadview-Greenwood;
 - (vii) Ward 31, Beaches-Woodbine;
 - (viii) Ward 32, Beaches-Woodbine.
- (f) the East Community Council shall include:
- (i) Ward 35, Scarborough Southwest;
 - (ii) Ward 36, Scarborough Southwest;
 - (iii) Ward 37, Scarborough Centre;
 - (iv) Ward 38, Scarborough Centre;
 - (v) Ward 39, Scarborough-Agincourt;
 - (vi) Ward 40, Scarborough-Agincourt;
 - (vii) Ward 41, Scarborough-Rouge River;
 - (viii) Ward 42, Scarborough-Rouge River;
 - (ix) Ward 43, Scarborough East;
 - (x) Ward 44, Scarborough East.

3. This By-law shall come into effect on December 1, 2000.
