**CITY OF TORONTO**

**BY-LAW No. 7-2001**

**To appoint members of the City Council as members and alternates  
of the Greater Toronto Services Board.**

WHEREAS the Greater Toronto Services Board Act, 1998 (the "Act") requires the Council of the City of Toronto to appoint ten of its members as members of the Greater Toronto Services Board; and

WHEREAS the Act provides that the Council of the City of Toronto may appoint alternates for the members of the Board who are appointed by the Council and an alternate for the Mayor of the City of Toronto; and

WHEREAS the Act provides that the members of the Board representing the City of Toronto shall have four additional votes, distributed among the members as determined by the Council of the City of Toronto, with respect to matters set out in Part II of the Act and in elections of the chair of the Board;

The Council of the City of Toronto HEREBY ENACTS as follows:

**1.** The following Members of Council are appointed as members of the Greater Toronto Services Board in addition to Mayor Mel Lastman, who is a member of the Greater Toronto Services Board by virtue of his office:
