CITY OF TORONTO

BY-LAW No. 99-2001

**To amend the former City of Toronto Municipal Code Ch. 400,
Traffic and Parking, respecting Bain Avenue, Baltic Avenue, Drayton Avenue,
Villiers Street, Withrow Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
