**CITY OF TORONTO**

**BY-LAW No. 121-2001**

**To amend By-law No. 31878, as amended, of the former City of North York.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. That Section 1 of By-law No. 31878 of the former City of North York, is amended by deleting the following:
