CITY OF TORONTO

BY-LAW No. 132-2001

To expropriate certain lands for the establishment of a public lane east of Huntley Street extending between Linden Street and Selby Street.

WHEREAS notice of an application to the Council of the City of Toronto for approval to expropriate the lands hereinafter described for public lane purposes has been served on the registered owners thereof and has been published pursuant to the provisions of the *Expropriations Act*; and

WHEREAS no notice in writing of a desire for a hearing has been received with respect to such lands and the time for giving such notice has expired;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The expropriation of the lands described in sections 2 and 3 hereof is hereby approved pursuant to section 8 of the *Expropriations Act*.
2. A portion of the private lane east of Huntley Street extending between Linden Street and Selby Street, being Parts of Lots 17, 18 and 19 on Plan 132-A, in the City of Toronto, designated as Part 1 on Plan 64R-16234, both said Plans being in the Land Registry Office for the Metropolitan Toronto Registry Division (No. 64), is hereby expropriated and taken for public lane purposes and for all works and uses ancillary thereto pursuant to the provisions of subsection 191(1) of the *Municipal Act*.
3. A portion of the private lane east of Huntley Street extending between Linden Street and Selby Street, being Part of Lot 19 on Plan 132-A, in the City of Toronto, designated as Part 2 on Plan 64R-16234, both said Plans being in the Land Registry Office for the Metropolitan Toronto Registry Division (No. 64), is hereby expropriated and taken for public lane purposes and for all works and uses ancillary thereto pursuant to the provisions of subsection 191(1) of the *Municipal Act*.
4. Authority is hereby granted for the signing, sealing and registration in the proper Land Registry Office of the plans showing the lands expropriated pursuant to sections 2 and 3 hereof, including the payment of all expenses incidental thereto.
5. The Director of Real Estate is hereby authorized to sign, and serve on the registered owners of the properties described in sections 2 and 3 hereof, the Notices of Expropriation, the Notices of Election as to a Date for Compensation and Notices of Possession as contemplated by the *Expropriations Act*.

- 6.** The Mayor and the proper officers of the City are hereby authorized and directed to do all things necessary to give effect to this by-law and the City Clerk and the Chief Financial Officer and Treasurer are hereby directed to execute all documents necessary in that behalf, and the Chief Financial Officer and Treasurer is authorized and directed to affix the corporate seal of the City to all such documents.
