## CITY OF TORONTO

### BY-LAW No. 135-2001

#### To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Abbott Avenue, Blackthorn Avenue, Emerson Avenue, Galley Avenue, Lappin Avenue, Maria Street, Northcote Avenue, Symington Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Emerson Avenue	East	A point 55 metres north of Wallace Avenue and a point 5.5 metres further north	Anytime
Northcote Avenue	East	A point 61.6 metres north of Queen Street West and a point 5.5 metres further north	Anytime

B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Abbott Avenue	South	A point 110.5 metres west of Dundas Street West and a point 5.5 metres further west thereof	Anytime
Blackthorn Avenue	West	A point 96.5 metres south of Rowntree Avenue and a point 5.5 metres further south thereof	Anytime
Galley Avenue	North	A point 213 metres east of Roncesvalles Avenue and a point 5.5 metres further east thereof	Anytime

Lappin Avenue	North	A point 12.3 metres west of Emerson Avenue and a point 5.5 metres further west thereof	Anytime
Maria Street	South	A point 54.6 metres east of Runnymede Road and a point 5.5 metres further east thereof	Anytime
Symington Avenue	East	A point 54.2 metres north of Wallace Avenue and a point 5.5 metres further north thereof	Anytime
