**CITY OF TORONTO**

**BY-LAW No. 174-2001**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Adelaide Street West, Mansfield Avenue, Niagara Street, Ossington Avenue, Shuter Street, St. Mary Street, Tecumseth Street, Euclid Avenue, Wellington Street West.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
