## CITY OF TORONTO

## BY-LAW No. 177-2001

To layout and dedicate certain land bounded by Lawrence Avenue East and East Avenue for public highway purposes and to name one portion of that public highway "Frank Faubert Drive" and the other portion "Wuthering Heights Road".

WHEREAS the City has acquired certain lands as hereinafter described and the Council of the City deems it appropriate and necessary to accept the said lands as a Public Highway; and

WHEREAS subsection 1(a) of Section 297, of the Municipal Act, R.S.O. 1990, Chapter M.45 provides that the Council of every municipality may pass by-laws for establishing and laying out highways; and

WHEREAS subsection 111 of Section 210, of the Municipal Act, R.S.O. 1990, Chapter M.45 provides that by-laws may be passed by the Councils of local municipalities to provide for surveying, settling and marking the boundary lines of highways and giving names to them;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. The lands described as parts of Blocks 121, 122, 123, 125 and 126 on Plan 66M-2129, designated as Parts 6, 7 and 8 on Plan 66R-18601 in the City of Toronto (formerly City of Scarborough), more particularly described in Schedule "A" attached hereto, which forms part of this By-law, are hereby established and laid out as public highways within the City to be known as Frank Faubert Drive and Wuthering Heights Road.
- 2. The land dedicated for public highway purposes under section 1 of this By-law are named Frank Faubert Drive and Wuthering Heights Road as more particularly detailed on the sketch in Plan SYE2953 dated September 27, 2000 (Schedule "B") attached to this By-law.
- 3. All By-laws presently in force with respect to highways and streets shall apply to the said highways created under this By-law.


