CITY OF TORONTO

BY-LAW No. 195-2001

To repeal various Business Improvement Area Boards of Management appointments by-laws of the former Municipalities of East York, Etobicoke and York and to set the size and quorum of the Boards of Management of the Business Improvement Areas located in the former Municipalities of East York, Etobicoke and York.

WHEREAS by the adoption of Clause No. 14 of Report No. 3 of the Economic Development and Parks Committee on April 23, 24, 25, 26, 27, 30 and May 1 and 2, 2001, City of Toronto Council approved the appointment of members to various Business Improvement Area Boards of Management for a term expiring on November 30, 2003, or until their successors are appointed; and

WHEREAS it is necessary to repeal a by-law of the former City of York appointing members to one of the Business Improvement Area Boards of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Council hereby sets the size and quorum of various Boards of Management of the Business Improvement Areas for the former Municipalities of East York, Etobicoke and York as listed in Schedule "A" attached hereto.
2. The enactment of this by-law repeals the following by-laws:
 - (1) former City of Etobicoke By-law No. 1986-176; By-law No. 1987-231; By-law No. 1989-33; By-law No. 1989-201; By-law No. 1990-71; By-law No. 1991-31; By-law No. 1992-56; By-law No. 1993-164; By-law No. 1995-39 and By-law No. 1995-52; and
 - (2) former City of York By-law No. 3466-97.
3. To the extent of any conflict between this by-law and any other by-law, this by-law prevails.
