### **BY-LAW No. 210-2001**

#### **To amend By-law No. 31001 of the former City of North York, as amended.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "B" of By-law No. 30662, of the former City of North York, is amended by deleting from Columns 1, 2, 3, 4 and 5, the following:
