CITY OF TORONTO

BY-LAW No. 253-2001

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Duncan Street, Pearl Street, Simcoe Street.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXX (Parking Meters) in § 400-83, the following in alphabetical order by street name:
