CITY OF TORONTO

BY-LAW No. 316-2001

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Annette Street, Edwin Avenue, Geary Avenue, Runnymede Road, West Toronto Street, Weatherell Street.

The Council of the City of Toronto HEREBY ENACTS as follows:
