CITY OF TORONTO

BY-LAW No. 329-2001

To amend By-law No. 188-2000 and City of Toronto Municipal Code Chapter 910, Parking Machines, respecting the amount of voluntary payments and set fines for offences relating to the use of parking meters and parking machines.

WHEREAS By-law No. 188-2000 establishes voluntary payments for penalites for parking meter and parking machine offences at \$15 and set fines have been established at \$20 for these offences; and

WHEREAS Council wishes to establish voluntary payments and set fines for Bus and Delivery Vehicle Parking Zones and Bus Loading Zones for parking meter and parking machines offences which exceed the \$15 and \$20 amounts, subject to any necessary Provincial approval;

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. By-law No. 188-2000, being "A By-law to amend current City of By-laws No. 3742 (North York), No. 22614 (Scarborough), No. 107-86 (Metro), No. 197 (East York), No. 1645-89 (York), and Municipal Code Chapters 400 (Toronto), 982 (York) and 187 (Etobicoke) respecting the use of parking meters, and By-law No. 912-1998 respecting the use of parking machines, to establish new voluntary payment amounts with respect to offences." is amended by adding a new Section 10.1 as follows:
 - "10.1 Despite Section 10 of this By-law, this By-law does not apply to voluntary payments and set fines for Bus Parking and Delivery Vehicle Parking Zones and Bus Loading Zones for parking meter and parking machine offences".
- 2. City of Toronto Municipal Code Chapter 910, Parking Machines, is amended by adding a new Section 910.10.1, as follows:
 - § 10.1 Despite § 910-10 the penalties for the commission of a parking offence respecting parking meter and parking machines in Bus and Delivery Vehicle Parking Zones and Bus Loading Zones under this Chapter, By-law No. 107-86 of the former Municipality of Metropolitan Toronto and Municipal Code, Chapter 400, Traffic and Parking of the former City of Toronto, may be greater than the amounts set out in Section 10 of this Chapter".

3. By-law No. 620-2000, being "A By-law to amend By-law No. 542-1999 to exclude Bus and Delivery Vehicle Parking Zones and Bus Loading Zones from the application of By-law No. 542-1999 respecting the amount of voluntary payments and set fines for offences relating to the use of parking meters and parking machines." is repealed.
