#### LANDS AFFECTED BY THIS AMENDMENT

This amendment concerns the lands located at 8 – 10 Altamont Road

# EFFECT OF AMENDMENT

The effect of this amendment would be to redesignate the lands at 8 –10 Altamont Road from RD-1 to RD-2.

#### **PUBLIC MEETINGS**

The North York Community Council considered Amendment Application UDOZ-99-46 at a statutory public meeting held on September 20, 2000, after written notice of such meeting had been sent to all persons assessed in respect of land and to all tenants within 120 metres of the subject lands. It was North York Community Council's decision to recommend approval of the application.

A meeting to consider this matter was held by Council of the City of Toronto on October 3, 4 and 5, 2000, and its Special Meetings held on October 6, 10, 11 and 12, 2000. Council adopted the recommendation of the North York Community Council to approve the application.

On June 1, 2001, Council enacted By-law No. 469-2001 which approved this amendment.
