CITY OF TORONTO

BY-LAW No. 472-2001

To amend Chapter 910, Parking Machines, of the Municipal Code of the City of Toronto, to replace parking meters with parking machines on certain portions of Sherbourne Street and Spadina Avenue.

WHEREAS, by the *City of Toronto Act, 1997 (No. 2)* and the *Municipal Act*, the Council of the City may delegate to the Toronto Parking Authority the construction, maintenance, operation and management of parking operations and facilities; and

WHEREAS City Council has directed that the responsibility for on-street parking meter and parking machine facilities within the City of Toronto is transferred to the Toronto Parking Authority and has authorized the City Solicitor, upon the certification of the President of the Parking Authority, to process by-law amendments with respect to the replacement of meters with machines;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 910, Parking Machines, of the Municipal Code of the City of Toronto is amended by:

(1) Deleting the following from Schedule I in alphabetical order:
