BY-LAW No. 475-2001

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Chesley Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Chesley Avenue	South	Entire length	Anytime

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Chesley Avenue	South	Entire length	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

C. By deleting from Part A of Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)	(From Column 5)
Chesley Avenue	Even	From the east end of Chesley Avenue to Brock Avenue	9	All times

D. By inserting in Part A of Schedule XXVI (Permit Parking) in § 400-79, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)	(In Column 5)
Chesley Avenue	Even	From the east end of Chesley Avenue to Brock Avenue	9	All times, except no parking 16th day to the last day of each month, inclusive, from Apr. 1 to Nov. 30, inclusive
Chesley Avenue	Odd	From the east end of Chesley Avenue to Brock Avenue	9	All times, except no parking first day to the 15th day of each month, inclusive, from Apr. 1 to Nov. 30, inclusive; and no parking anytime from Dec. 1 of one year to Mar. 31 of the next following year, inclusive

E. By inserting in Schedule XXVIII (Alternate Side Parking) in § 400-81, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)	(In Column 5)
Chesley Avenue	South	Entire length	No parking; from Apr. 1 to Dec. 1	First day to the 15th day of each month, inclusive
Chesley Avenue	North	Entire length	No parking; from Apr. 1 to Dec. 1	16th day to the last day of each month, inclusive
