## **CITY OF TORONTO**

## BY-LAW No. 506-2001

To Appoint an Acting Chief Administrative Officer, an Acting Chief Financial Officer, an Acting Treasurer and Collector, and an Acting Commissioner of Community and Neighbourhood Services Department and to amend Chapter 257, Signing Authority, of the City of Toronto Municipal Code.

WHEREAS, in accordance with sections 18 and 19 of the *City of Toronto Act, 1997*, the Council of the City of Toronto (the "Council") is deemed to have taken all steps required to appoint Michael Garrett to the position of Chief Administrative Officer for the City of Toronto (the "City"); and

WHEREAS, pursuant to By-law No. 343-2001, Council appointed Michael Garrett to the position of Interim Chief Financial Officer and Treasurer and to the office of collector for the City; and

WHEREAS, section 72 of the *Municipal Act* provides that a council may by by-law appoint a chief administrative officer who shall have such general control and management of the administration of the government and affairs of the municipal corporation and perform such duties as the council by by-law prescribes, and shall be responsible for the efficient administration of all its departments to the extent that he or she is given authority and control over them by by-law; and

WHEREAS, Article I of Chapter 169, City Officials, of the City of Toronto Municipal Code sets out the powers and duties of the Chief Administrative Officer; and

WHEREAS subsection 77(1) of the *Municipal Act* requires the council of a municipality to appoint a treasurer whose duties shall be those set out in the Act; and

WHEREAS subsection 85(1) of the *Municipal Act* requires the council of every local municipality to appoint as many collectors for the municipality as it considers necessary; and

WHEREAS Article III of Chapter 169, City Officials, of the City of Toronto Municipal Code sets out the powers and duties of the Chief Financial Officer and Treasurer; and

WHEREAS by By-law No. 36-1998 Council appointed Shirley Hoy to the position of Commissioner of Community and Neighbourhood Services for the City of Toronto.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. (1) The appointment of Michael Garrett to the office of Chief Administrative Officer for the City of Toronto is rescinded.

- (2) Shirley Hoy is appointed to the office of Acting Chief Administrative Officer for the City of Toronto, and shall have all the powers and duties imposed upon the Chief Administrative Officer by Article I of Chapter 169, City Officials, of the City of Toronto Municipal Code.
- 2. (1) The appointment of Michael Garrett to the office of Interim Chief Financial Officer and Treasurer and to the office of collector for the City of Toronto is rescinded, and By-law No. 343-2001 is repealed.
  - (2) Shirley Hoy is appointed to the office of Acting Chief Financial Officer for the City of Toronto, and subject to (4), (5) and (6), shall have all the powers and duties imposed upon the Chief Financial Officer and Treasurer by Article III of Chapter 169, City Officials, of the City of Toronto Municipal Code.
  - (3) Al Shultz is appointed to the office of Acting Treasurer and to the office of collector for the City of Toronto.
  - (4) Any collectors for the City of Toronto appointed by Council shall report to the Acting Treasurer.
  - (5) The Acting Treasurer shall report to the Acting Chief Financial Officer.
- 3. (1) Until such time as she ceases to hold the offices of Acting Chief Administrative Officer and Acting Chief Financial Officer for the City of Toronto, Shirley Hoy shall not have the powers and duties imposed upon the Commissioner of Community and Neighbourhood Services by Article IX of Chapter 169, City Officials, of the City of Toronto Municipal Code.
  - (2) Eric Gam is appointed to the office of Acting Commissioner of Community and Neighbourhood Services for the City of Toronto until such time as Shirley Hoy ceases to hold the offices of Acting Chief Administrative Officer and Acting Chief Financial Officer for the City of Toronto, and during such time shall have all the powers and duties imposed upon the Commissioner of Community and Neighbourhood Services by Article IX of Chapter 169, City Officials, of the City of Toronto Municipal Code.
- **4.** Section 257-1 of the City of Toronto Municipal Code is amended by adding the words "the Acting Treasurer or" before the words "the Director, Accounting Services or the Director, Treasury and Financial Services."
- 5. This by-law shall come into force on the 27th day of June, 2001.
