CITY OF TORONTO

BY-LAW No. 523-2001

To amend the former City of Toronto Municipal Code Chapter 20, Business Improvement Areas, to include the new Downtown Yonge Street Business Improvement Area Board of Management.

WHEREAS Chapter 20 Business Improvement Areas of the former City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas; and

WHEREAS by the adoption of Clause No. 18 of Report No. 6 of the Economic Development and Parks Committee on June 26, 27 and 28, 2001, City of Toronto Council approved the appointment of members to the new Downtown Yonge Street Business Improvement Area Board of Management for a term expiring on November 30, 2003, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of Municipal Code, Chapter 20, Business Improvement Areas of the former City of Toronto must be amended to include the new Downtown Yonge Street Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The table in Schedule A of the Municipal Code, Chapter 20, Business Improvement Areas, of the former City of Toronto, is hereby amended by deleting the table in Schedule A thereof and replacing it with Schedule A attached hereto.
