CITY OF TORONTO

BY-LAW No. 534-2001

To amend Chapter 400, Traffic and Parking, of the Municipal Code of the former Corporation of the City of Toronto, to replace parking machines with parking meters on certain portions of Queen Street East.

WHEREAS, by the *City of Toronto Act, 1997 (No. 2)* and the *Municipal Act*, the Council of the City may delegate to the Toronto Parking Authority the construction, maintenance, operation and management of parking operations and facilities; and

WHEREAS City Council has directed that the responsibility for on-street parking meter and parking machine facilities within the City of Toronto is transferred to the Toronto Parking Authority and has authorized the City Solicitor, upon the certification of the President of the Parking Authority, to process by-law amendments with respect to the replacement of machines with meters;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 400, Traffic and Parking, of the Municipal Code of the former Corporation of City of Toronto is amended by adding the following to Schedule XXX in alphabetical order:
