BY-LAW No. 585-2001

**To amend further By-law No. 92-93, a By-law “To regulate traffic on roads in the
Borough of East York”, being a by-law of the former Borough of East York.**

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule VIII (No Parking) of By-law No. 92-93, a By-law “To regulate traffic on roads in the Borough of East York”, as amended, being a by-law of the former Borough of East York, is further amended by striking out the words and figures:

Gledhill Avenue	East	King Edward Avenue to the South Borough Limit	Anytime
Gledhill Avenue	West	King Edward Avenue to the South Borough Limit	8:00 a.m. to 6:00 p.m.

where they occur opposite each other in Columns 1, 2, 3, and 4 of the said Schedule and inserting in alphabetical order in lieu thereof the following:

Gledhill Avenue	West	A point 79.0 metres north of Danforth Avenue and a point 46.0 metres further north thereof	8:00 a.m. to 5:00 p.m., Monday to Friday
Gledhill Avenue	East	A point 74.5 metres north of Danforth Avenue and King Edward Avenue	5:00 p.m. to 8:00 a.m., Monday to Friday; and Anytime Saturday and Sunday
King Edward Avenue (east/west leg)	North	The north/south leg of King Edward Avenue and a point 47.6 metres west of Gledhill Avenue	Anytime

2. Schedule IX (No Stopping) of By-law No. 92-93, as amended, is further amended by inserting the following words and figures in alphabetical order in Columns 1, 2, 3 and 4 of the said Schedule:

Gledhill Avenue	East	A point 74.5 metres north of Danforth Avenue and King Edward Avenue	8:00 a.m. to 5:00 p.m., Monday to Friday
Gledhill Avenue	West	A point 74.5 metres north of Danforth Avenue and a point 4.5 metres further north thereof	Anytime
King Edward Avenue (east/west leg)	North	Gledhill Avenue and a point 47.6 metres west thereof	8:00 a.m. to 5:00 p.m., Monday to Friday

3. Schedule X (Parking for Restricted Periods) of By-law No. 92-93, as amended, is further amended by inserting the following words and figures in Columns 1, 2, 3, 4 and 5 of the said Schedule:

Gledhill Avenue	West	A point 125 metres north of Danforth Avenue and a point 9.0 metres south of King Edward Avenue	8:00 a.m. to 5:00 p.m., Monday to Friday	10 mins.
