**AMENDMENT NO. 1068 TO THE OFFICIAL PLAN****OF THE FORMER CITY OF SCARBOROUGH****LAND ABUTTING THE EAST SIDE OF SILVER STAR BOULEVARD, SOUTH OF  
KILCULLEN CASTLE GATE, EXCLUDING LAND ABUTTING THE NORTH SIDE  
OF SILVER STAR BOULEVARD**

The following Text constitutes amendment No. 1068 to the Official Plan for the former City of Scarborough (being an amendment to the provisions of the Scarborough Official Plan, Secondary Plan for the Milliken Industrial District Secondary Plan).

The sections headed “Purpose and Location” and “Basis” are explanatory only, and shall not constitute part of this amendment.

**PURPOSE AND LOCATION:**

This amendment affects land abutting the East Side of Silver Star Boulevard, south of Kilcullen Castle Gate, excluding land abutting the North Side of Silver Star Boulevard

The amendment defines the area for permitted Place of Worship use.

**BASIS:**

The amendment clarifies the scope of permitted Place of Worship use in the subject area.

**OFFICIAL PLAN AMENDMENT:**

The Milliken Employment District Secondary Plan Text, is amended by substituting the existing Numbered Policy 1 with the following:

1. **Land abutting the East Side of Silver Star Boulevard, south of Kilcullen Castle Gate, excluding land abutting the North Side of Silver Star Boulevard**

Within the **Industrial Employment** designation as it applies to this land, Places of Worship will also be permitted.
