BY-LAW No. 717-2001

To amend further By-law No. 20-96, a by-law “To provide for overnight permit parking on Borough streets”, being a by-law of the former Borough of East York.

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule A of By-law No. 20-96, entitled “To provide for overnight permit parking on Borough streets”, as amended, being a by-law of the former Borough of East York, is further amended by deleting the following words and figures where they appear opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule:

- Schedule A of By-law No. 20-96, entitled “To provide for overnight permit parking on Borough streets”, as amended, being a by-law of the former Borough of East York, is further amended by inserting in Columns 1, 2, 3, 4 and 5 of the said Schedule, between the words “Inwood Avenue” and “King Edward Avenue” where they appear in Column 1 of the said Schedule, the following:
