BY-LAW No. 719-2001

To amend former City of Toronto Municipal Code Ch. 400, Traffic and Parking, Schedule XXVI (Permit Parking), by adding a new Part AE respecting Ryding Avenue and by adding a new Part AG respecting McMaster Avenue and by making a technical amendment to references to hours of parking in Part N.

WHEREAS Council of the former City of Toronto authorized technical amendments to be made to former City of Toronto Municipal Code Ch. 400, Traffic and Parking from time to time when necessary and it has been discovered that references to Part N of Schedule XXVI (Permit Parking) do not contain the correct hours for parking and it is appropriate to make this technical amendment;

WHEREAS in order to provide for permit parking between the hours of 6:00 p.m. to 9:00 p.m. Monday to Friday on Ryding Avenue, it is necessary to create a new Part AE of Schedule XXVI (Permit Parking) of former City of Toronto Municipal Code Ch. 400, Traffic and Parking;

WHEREAS in order to provide for permit parking between the hours of 2:01 a.m. to 10:00 a.m. Monday to Friday on McMaster Avenue, it is necessary to create a new Part AG of Schedule XXVI (Permit Parking) of former City of Toronto Municipal Code Ch. 400, Traffic and Parking.

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Municipal Code Ch. 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from §§ 400-38B and 400-38D(1): "ZZ, AB, AC or AD" and replacing it with: "ZZ, AB, AC, AD, AE or AG."
 - B. By deleting from § 400-38E under the heading "Permit Parking Hours" across from "Part N": "12:01 a.m. to 10:00 a.m." and replacing it with: "2:01 a.m. to 10:00 a.m."
 - C. By inserting in § 400-38E the following:
