**CITY OF TORONTO**

**BY-LAW No. 723-2001**

**To amend By-law No. 196-84 of the former City of York, being a By-law  
“To regulate traffic on City of York Roads”.**

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING – SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Charlton Settlement Avenue	east	Buttonwood Avenue and Sidney Belsey Crescent (north junction)	Anytime
Dora Spencer Road	south	Charlton Settlement Avenue and Weston Road	Anytime
Sidney Belsey Crescent	south and east and north	Weston Road and Charlton Settlement Avenue (south junction)	Anytime
Sidney Belsey Crescent	north and west and south	A point 40 metres east Westpoint Lane (north junction) and Westpoint Lane (south junction)	Anytime

ONE-WAY STREETS – SCHEDULE XII

2. That Schedule XII of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Between</u>	<u>Column 3</u> <u>Prohibited</u> <u>Times or Days</u>	<u>Column 4</u> <u>Direction</u>
Sidney Belsey Crescent	Westpoint Lane (north junction) and Westpoint lane (south junction)	Anytime	westbound and southbound and eastbound

THROUGH HIGHWAYS – SCHEDULE XVIII

3. That Schedule XVIII of former City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1 and 2 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Between</u>
Eileen Avenue	The west limit Lydon Avenue and the east limit Esposito Crescent

THROUGH HIGHWAYS – SCHEDULE XVIII

4. That Schedule XVIII of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1 and 2 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Between</u>
Eileen Avenue	The west limit Mildred Avenue and the east limit Esposito Crescent
Sidney Belsey Crescent	The east limit Pioneer Avenue (north junction) and the west limit Charlton Settlement Avenue

STOP SIGNS – SCHEDULE XIX

5. That Schedule XIX of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1 and 2 of said Schedule the following:

<u>Column 1</u> <u>Intersection</u>	<u>Column 2</u> <u>Stop Streets</u>
Charlton Settlement Avenue (south junction) and Sidney Belsey Crescent	Charlton Settlement Avenue for north and southbound traffic
Charlton Settlement Avenue (north junction) and Sidney Belsey Crescent	Charlton Settlement Avenue for northbound traffic
Eileen Avenue and Elvin Avenue	Eileen Avenue for east and westbound traffic
Elvin Avenue and Eileen Avenue	Elvin Avenue for northbound traffic
Lydon Avenue and Eileen Avenue	Lydon Avenue for northbound traffic
Sidney Belsey Crescent (north junction) and Charlton Settlement Avenue	Sidney Belsey Crescent for east and westbound traffic
