**BY-LAW No. 750-2001**

**To amend By-law No. 31001 of the former City of North York, as amended.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule "XVIII" of By-law No. 31001, of the former City of North York, is amended by deleting from Columns 1 and 2 the following:
